bike; they learned how to play well with each other, how to listen to and follow directions, and they got to be active for 30 minutes during their school day, which improves their writing and listening skills. One teacher at Eastern Elementary says she always notices an improvement in the kids' abilities after "bike club". These pre-schoolers leave the Estrellas Balance Bike program with the confidence to continue riding bikes, and more likely to be active for life.

Norte's after school, adventure-based, bike safety program reached 5 elementary schools in 2017: Willow Hill, Central Grade, Glenn Loomis, Immaculate Conception, and Traverse Heights. Through the spring and fall program, 21 fourth, fifth and sixth-graders pedaled around Traverse City to learn the rules of safe bicycle riding, and to put those lessons into action. Each student pedaled up to 25 miles over the course of the program, and visited several parks and natural attractions.

Norte's Bike Más Summer Camp expands on the successes of the After School Bike Más Project. Bikecampers explore the Traverse City area by bike for 3 hours a day for 5 days from June to August. 85 kids participated in 2017, pedaled themselves from 5 to 13 miles each day, and visited over 20 area parks. Norte's initial Youth Mountain Bike season attracted 21 students from ages 9 to 15 to fill out its JV andVarsity teams. The team riders practiced 2 to 3 days a week for 5 week, culminating in a spectacular showing at the Iceman Cometh Challenge in November: 62 youth racers toed the line wearing Norte orange!
